Course Description

Theory has always been at the heart of Sociology. From its origins in the work of Karl Marx, Max Weber and Émile Durkheim, theoretical thinking has guided the sociological project through its many transformations and formulations. This course focuses on the development of sociological theory from the Second World War to the present. In particular, it focuses on the work of three influential social theorists: Michel Foucault, Pierre Bourdieu, and Walter Benjamin. Theory, however, is always a conversation between authors and as such, other authors (Derrida, Baudrillard, De Certeau, Hall among others) will also be discussed to grasp the complex connections between social theorists and their worlds of thought.

Course Objectives/Learning Outcomes

This course will provide the students with the opportunity to:

- 1. Explore the thought of Michel Foucault, Pierre Bourdieu and Walter Benjamin.
- 2. Grasp the complex relationships between these authors and other social thinkers.
- 3. Understand important theoretical concepts such as "normalizing gaze", "distinction" and "aura".
- 4. Examine and discuss foundational books from Foucault, Bourdieu and Benjamin.
- 5. Develop an understanding of Contemporary Sociological Theory.

Course Format

This course will have a Hybrid format. This means that it will require both synchronous and asynchronous involvement by students. In terms of synchronous involvement, we will have one-hour lecture sessions on Mondays and Wednesdays from 1 to 2 pm. These lectures will be recorded for those that cannot access them in real time. Lectures notes will be also posted on D2L. In terms of asynchronous involvement the course will include online discussions, assignments and reading reports to be completed by students outside of lecture time. The due dates for these activities will be indicated over lecture and in D2L.

Class Activities are online exercises designed to enhance the understanding of the topics discussed in class. They should be completed in the week when they are posted in D2L to provide the possibility of class discussions and involve students in the learning process. They only will be accepted at a later date if students have a valid reason for the delay in submitting them.

Assignments will be completed individually and will evaluate students' understanding of the readings and assigned papers. The dates when they are due are detailed in the "Assignments Outline" in D2L.

Assignments not submitted in their due date will receive a penalty of one point off per day (on a scale of ten) unless students receive an extension from the instructor. Students must provide a valid reason to obtain this extension.

Presentations will be assigned individually. Each student will present to the instructor through zoom a theoretical theme regarding the authors being discussed (previously discussed with the instructor). Details regarding the presentations can be found in the "Presentation Outline" in D2L.

The **Reading Reports** will consist of short-answer questions related to the readings that we will do in this course. There will be four of them, one per each of the readings.

The **Final Project** will be a paper in which the students will present their analysis of one of the concepts, theories or authors discussed in the course. More information regarding the final project can be found in the "Final Project Outline" in D2L.

Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a reassessed grade may be raised, lowered, or remain the same.
