Introduction

In objective, subjective, and socially constructed terms, youth crime is an important issue in Canadian society. Youths who engage in serious crime are at a high risk for committing crime in adulthood. Many Canadians believe that convicted juveniles receive lenient punishments and consequently, continue to re-offend. This course will examine how and why young Canadians become involved in crime. Specific attention will be on rates of youth crime, the influence of gangs, substance abuse, sexual exploitation, homelessness, and responses to youth crime. Upon successful completion of this class, students will be able to apply and analyze leading sociological approaches to youth crime, and discern between the objective "facts" surrounding youth crime from it being a socially constructed problem.

Objectives

To identify key trends in youth crime.

To explain the effects of media upon thinking about youth crime.

To explain the key components of the Youth Criminal Justice Act.

To summarize major theories on youth crime.

To identify and evaluate important changes to the treatment of criminal youth.

Required Texts

The following text is required in this course:
