## Course Description

An examination of the fundamental conceptions of rights and freedoms in the works of J.S. Mill and twentieth- and twenty first-century philosophers. The treatment of these concepts in contemporary law and their role in contemporary legal and social issues are explored as well.

## Course Objectives/Learning Outcomes

To understand the arguments for tolerance/free speech classically expounded by John Stuart Mill, including the limits he placed on his arguments and the shortcomings of his arguments.

## Course Format

The course will be run asynchronously. There are no required scheduled meetings with the instructor. Students may check in through scheduled Zoom meetings once per week, but these are not required.

Students can also interact with the Instructor or T.A. through the D2L message boards and chats to access assistance and guidance with the reading assignments.

Students will work together towards the completion of three writing assignments. This can take place through the D2L message boards, chats, and Zoom meetings within your assigned peer groups.

### Required Textbooks, Readings, Materials, Electronic Resources

There are no textbooks required for this course. Students may wish to purchase one of the inexpensive editions of Mill's *On Liberty* that are commonly available in bookstores. There is also a new translation of *On Liberty* available in Kindle format available through Amazon (the Kindle app can be downloaded for free and is readable on both Mac and PC). Information on how to access this version of *On Liberty* will be posted in D2L.

## Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a re-assessed grade may be raised, lowered, or remain the same.
