Course Description

This course centers on multivariate statistics for survey data and measurement issues in quantitative research. Topics include multiple regression, dummy variable regression, statistical interaction and path analysis, among others. Labs will provide students with practical knowledge for the analysis of quantitative data. Using statistical software, they will develop measurement and causal models for the study of social issues.

Course Objectives/Learning Outcomes

This course will provide the students with the opportunity to:

1. Examine the role of multivariate statistical concepts in the study of social issues.
2. Understand and apply various statistical concepts used in quantitative data analysis.
3. Use SPSS to run and analyze multiple regression models.
4. Better grasp quantitative methodologies and the importance of multiple regression for the analysis of quantitative data.

The **Midterm examinations** will include a mixture of multiple choice, short answers and calculation problems. They are non-cumulative (they could be indirectly cumulative because statistical analysis always builds on previous formulas and concepts). They will take place during lecture's hours as detailed on the reading schedule. The use of one double-sided, letter-sized, written or printed, study sheet will be permitted during midterm examinations.

Type	The final exam will include a mixture of multiple choice, short answers and calculation problems. It is cumulative but mostly focused in the third part of the course (content after the second midterm). The final exam will be registrar-scheduled. The date, time and location will be posted to D2L once this information becomes available to the instructor.

Aids	The use of calculator and of two double-sided, letter-sized, written or printed, study sheets will be permitted during the final examination.
