Course Description

Media texts are all around us. Broadcasted in Television, as memes on the Internet, wore as a t-shirt in the street. Media reaches every corner of Society, interacting with communities and individuals through a variety of messages and narratives. The complex interrelations between media and society constitute the object of study of this course. Employing a critical approach informed by Cultural Studies, Media and Society explores the many forms in which our understandings of gender, ethnicity, and other social phenomena, are informed and in turn inform the many mediascapes that characterize the contemporary world. By analyzing media such as cinema, television, videogames, animation and the Internet, as well as their respective audiences, this course intends to delve into the interconnections between modern subjectivity and the imagined worlds of mass and new media.

Course Objectives/Learning Outcomes

This course will provide the students with the opportunity to:

1. Understand the central ideas of important theorist of media such as Theodor Adorno, Walter Benjamin, and Stuart Hall.
2. Grasp the complex relationships between media representation and society.
3. Employ a critical approach to explore media texts and its depictions of gender, ethnicity, etc.
4. Explore the interrelationship between culture industries, audiences and popular culture.
5. Develop an understanding of the interconnections between modern subjectivity and the imagined worlds of media.

Course Format

This course will have a Hybrid format. This means that it will require both synchronous and asynchronous involvement by students. In terms of synchronous involvement, we will have one-hour and fifteen minutes lecture sessions on Mondays and Wednesdays from 1 to 2:15 pm. These lectures will be recorded for those that cannot access them in real time. Lectures slides will be also posted on D2L. In terms of asynchronous involvement the course will include presentations, assignments and reading reports to be completed by students outside of lecture time. The due dates for these activities will be indicated over lecture and in D2L.

Presentations will be assigned in teams of two or individually. Each student will present to the instructor through zoom a theoretical theme regarding the authors being discussed (previously discussed with the instructor). Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then book a time with the student to discuss his or her work and rationale. It should be noted that a re-assessed grade may be raised, lowered, or remain the same.

***Media recording for lesson capture**
