Course Description

This course is about the social organization of criminal justice in Canada. While Sociology 327 introduced students to the basic operation of the Canadian criminal justice system, this course explores shortcomings of the justice system. That is, the course considers how it does not live up to its stated objectives. We will consider why many citizens believe that crime is rampant and the system too lenient on criminals. As well, we will explore how class ideology generates and perpetuates inequities in terms of policing, sentencing, and sanctioning. Lastly, we will look at prospects for change in Canadian criminal justice. Upon successful completion of this course,

students should be able to identify problems in the operation of the criminal justice system and think critically about positive social change.

Course Objectives/Learning Outcomes

To identify and explain the philosophical principles of the Canadian justice system.

To identify how social inequities influence policing, sentencing, and sanctioning.

To explain how a lack of community affects crime rates.

To apply pyrrhic defeat theory and broken windows theory to instances of crime in Canada.

To evaluate the arguments posed by Reiman/Leighton and Wilson, and make suggestions for improving social justice in Canada.

Course Format

Lectures for this course will be delivered via Desire2Learn (D2L). There will be PowerPoint slide shows with embedded video for students to consider along with various news items. The class will be run with asynchronous involvement of students. In other words, there are no precise lecture times for students to attend. Rather, documents can be retrieved at any time. Of course, there are specific due dates for assignments (see below).

Students will be asked to consider news items on D2L from time to time. No other electronic resources will be used.

Learning Technologies and Requirements

Although we will not have face-to-face lectures, I have included a schedule of lectures on D2L. Students should ensure that they have reviewed the lectures according to the schedule.

Methods of Assessment and Grading Weights

There are two opportunities for students to capture their grades. The first is a 7-10 page written assignment worth 50% of your grade due on Oct 15. More precise details about that assignment are available on D2L. The second assignment is an essay 7-10 pages long worth 50% due Nov 26. For both assignments, students will be given a choice of questions posted on D2L a week in advance of the deadlines, and upload their papers to the dropbox.

Final Exam Information

There is no final examination in this class.

Passing Grades

In order to pass the course, students must obtain 50% or more overall as per the grading scale.

Grade Reappraisal

Within two weeks of the date the exam/assignment is returned, students seeking reappraisal of examinations or assignments must submit a written response to the instructor explaining the basis for reconsideration of one's mark. The instructor will reconsider the grade assigned and will then

book a time with the student to discuss his or her work and rationale. It should be noted that a re-assessed grade may be raised, lowered, or remain the same.

Handing in Papers, Assignments

1. The main Sociology Department office does not deal with any course-related matters. Please speak directly to your instructor.
